Since online payments are accepted through credit card and at present we accept Master and Visa Card only. These charges are as per credit card service provider and this charge goes to the Payment gateway agency towards availing the Credit facility through Card and it does not come to the SuperSeva Services . The current charge of 2.2 % may vary as per the credit card agencies/ banking practices, these charges are controlled by the payment gateway provider and could change in future.

Service use obligations

# **Refunds & Cancellations**

In cases, where SuperSeva has not yet, initialized the order/request, SuperSeva might consider to cancel the order. But this is solely under the discretion of SuperSeva.
